#### **NEW BUSINESS**

a. City Manager, Bill Sawyer - Discussion of Petition of Annexation regarding 111.5 acres located on Highway 17 approximately 0.19 miles south from the intersection of Highway 17 and Highway 119.

Sawyer discussed the Annexation process. The City will send a Letter to the County Board of Commissioners and the County has 30 days to approve the Annexation. Then the City will come back before the Planning and Zoning Committee and ask for a recommendation. Gerwig questions the zoning. Sawyer states that Gerwig needs to ask the Developer. The City will have to have Public Hearings, signs must be posted, and letters mailed to the surrounding property owner and to the owner of the land being annexed. Lee asked what kind of houses are going to be built on this property. Sawyer then describes the Permit process with the City. Each home must have a Permit. Clayton Marsh owns 58 acres that are on the back side of the property being annexed. Marsh is concerned about flooding issues and how it is going to affect his property. Sawyer states that Marsh needs to come to the Public Hearing and ask all those questions. Sawyer then discusses Surety Bonds. Gerwig asked about a Performance Bond.
